Sub: Report of Scrutinizer on Voting Process conducted pursuant to the provision of Section 108 and 110 of the Companies Act, 2013 ('the Act') read with Companies (Management and Administration) Rules, 2014 and MCA Circulars

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, MCA Circulars and Rules relating to e-voting on the resolutions contained in the Notice of Postal Ballot dated Wednesday, February 11, 2026. 
We submit our report as under:

1. The Company had completed dispatch of the Notice of Postal Ballot through electronic mode on Tuesday, February 17, 2026 to its members, whose name(s) appeared on the Register of Members / list of beneficiaries as on the cut off date. i.e., Friday, February 13, 2026.
2. The Company has engaged the services of National Securities Depository Limited (NSDL) as the Authorised Agency to provide secured system for E-voting process.
3. The e-voting period remained open from 9.00 a.m. (IST) on Wednesday, February 18, 2026, and ends at 5.00 p.m. (IST) on Thursday, March 19, 2026.



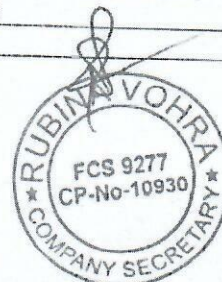

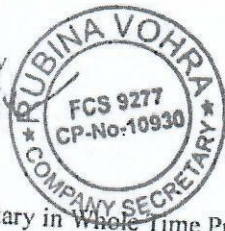
The proposed resolutions have therefore been passed with requisite majority by the Shareholders of the Company.
